## MONTGOMERY COUNTY SUPERVISOR OF ASSESSMENTS OFFICE GENERAL HOMESTEAD EXEMPTION APPLICATION FOR SINGLE FAMILY DWELLINGS SUBJECT TO A LEASE (35 ILCS 200/15-175) AS AMENDED BY PUBLIC ACT 97-1125

## **Section 1: Instructions**

- The property must be a single-family home occupied as the primary residence by an eligible taxpayer as of January 1 of the tax year.
- A notarized application for the exemption, signed by both the owner and the lessee of the property, <u>must be submitted</u> by January 31 of each year.
- A copy of the lease must be filed with the chief county assessment officer by the owner of the property at the time the notarized application is submitted. <u>If lessee is the same person that occupied the residence January1st of the prior year</u>, a new lease is not needed.
- The lease must expressly state that the lessee is liable for the payment of property taxes; and **the lease must include the following language in substantially the following form:**
- "Lessee shall be liable for the payment of real estate taxes with respect to the residence in accordance with the terms and conditions of 35 ILCS 200/15-175. The permanent real estate index number for the premises is (insert number),\and, according to the most recent property tax bill, the current amount of real estate taxes associated with the premises is (insert amount) per year. The parties agree that the monthly rent set forth above shall be increased or decreased prorata (effective January 1 of each calendar year) to reflect any increase or decrease in real estate taxes. Lessee shall be deemed to be satisfying Lessee's liability for the above mentioned real estate taxes with the monthly rent payments aset forth above (or increased or decreased as set forth herein)."
- · If there is a change in lessee, or if the lessee vacates the property, the chief county assessment officer must be notified of the change.
